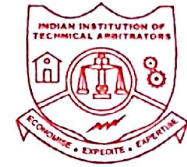

I am enclosing copies of Conference Brochure along with delegate registration and sponsorship/advertisement forms.


I request you to support the conference by deputing senior/middle level officers from your organization as delegates and also sending contributions/advertisements for souvenir to be released on this occasion.
